## 2007-2008 Annual Report: Rules, Procedures and Agenda Committee

During the 2007-2008 Academic Year, the RP&A committee met 17 times. Agendas and minutes from all meetings were posted on the Faculty Senate web site.

The meetings were well attended by the voting members. There was active participation by both the undergraduate and graduate student members of the committee, along with the president of the Graduate Faculty. The committee occasionally invited selected administrators to participate, and all who were invited did so.

The committee functioned essentially as the executive committee for the Academic Council / Faculty Senate.

Some of the issues discussed at the committee are listed below. In most cases, far more information can be obtained from the RP&A and Faculty Senate minutes.
