Friends, Senators, Colleagues.... I hereby call a Special Meeting of the Faculty Senate for Thursday, June 12, 2014 at 1:30 pm in McNutt 204. The sole agenda item is amending the bylaws. I will send the proposed revision (this is mostly about the process of hiring deans) not later than Monday for your consideration.

The odd timing, rather than discussing this at our 19 June meeting, is to follow the timeline required under the bylaws in such a way that the changes may be on the agenda of the July meeting of the Board of Curators. System wants the amendment one month ahead to have Counsel go through the text, and General Faculty must vote prior to that, and prior to that....
