#### 4. Overview of Virtual CLC Status and Potential

##### **Agenda Item #4: Overview of Virtual CLC Status and Potential**

At the last ITCC retreat, Eric Sigler made a presentation introducing the concept of virtual desktop infrastructure and “cloud” computing. With help from Eric and his team, EdTech is now running pilot using this technology to produce a “Virtual CLC” environment to support several distance courses (6 ERP courses and 1 TechComm course). We now have a platform that is scalable, and the pilot is going well.

Benefits of Virtual CLCs:

- Removes geographical constraints on both users and technical support staff.
- As the virtual platform is scaled up, the cost per virtual desktop becomes less than physical machines.
- Provides the same CLC experience for on campus and remote users.
- Shifting the balance of the CLC platform from purely physical to some physical/some virtual will free up classroom space.

Long term planning for CLC computing should include Virtual CLCs. Almost 98% of the incoming freshman class has one or more computers. 95% have laptops; 22% have desktops; 16% have both
